



In order to better serve the environmental horticulture or green industry, the Center for Applied Nursery Research (CANR) seeks an evaluation of its structure, operational conduct, and performance as perceived by the industry participants it serves. Before completing the survey instrument, please read the overview as to how the CANR sees itself and its role.

CANR is a non-profit organization that provides funding and facilities for green industry needs-driven research in an operational nursery setting. Located on 2 acres adjacent to McCorkle Nurseries in Dearing, Georgia, CANR is funded by special events and donations from industry & individuals.

The purpose or mission of CANR is to: (1) provide a managed facility and funding for ornamental horticulture research based on grower needs, and conducted under commercial growing conditions; (2) generate information to keep growers in Georgia and the Southeastern US on the forefront of new ornamental plant breeding, evaluation and introduction, as well as new nursery production techniques; and (3) provide a forum for the sharing of research results with the ornamental horticulture industry. Research projects also focus on agricultural engineering, environmental and plant microclimate monitoring, entomology, plant pathology, soil science, and water management. There were 15 projects for the year 2007 directed by researchers from the University of Georgia, University of Florida, and Auburn University.

The Board of Directors that governs the operation of CANR consists of industry representatives plus University of Georgia faculty. The research projects are developed from a list of needs submitted by participants in the green industry. The research proposals submitted by the researchers are reviewed and ranked by an Advisory Council that, in turn, presents its findings to the Board of Directors for funding approval. Each fall, an open house is held at CANR whereby the researchers present summaries of their projects, and articles of their research are published in the Georgia Green Industry Association's Journal and made available at industry trade shows, conferences and website.
